- 1.) Permit must be carried in the vehicle.
- 2.) Speed limit not to exceed 35 MPH
- 3.) Normal legal loading only
- 4.) Travel only between the hours of
- 5.) The Barry County Road Commission and/or their designate have the right to suspend this agreement if weather or road conditions warrant such actions without prior notice to the permit holder
- 6.) Any of the following actions shall immediately void this permit and subject the applicant to appropriate legal action:
 - a.) Misrepresentation of information set forth in the application for permit
 - b.) Noncompliance with the conditions, restrictions, and/or provisions on which the permit is issued.
 - c.) A change or erasure on the permit.
- 7.) The permittee shall be responsible for damages to the roadway, to persons, and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Barry County Road Commission, its Board of Commissioners, and all of their employees from any and all suits, claims, and damages of any kind arising out of, or any reason of this permit or from operations covered by this permit.
